**Corporate, Partnership, or Trust Land Owner Ballot Request**

According to 7-13-2254, M.C.A, where a corporation owns real property within the boundaries of the district, the president, vice-president, or secretary of such corporation shall be entitled to cast a vote on behalf of the corporation. 7-13-2212 further provides that an individual who is the owner of real property in the district need not be a resident of Montana and the County provided that such individual registered to vote in any state of the United States and files proof of such registration with the Election Administrator **at least 40 days prior to the election.**
